TAP Funds and Purpose of Planning Process

The Transportation Alternatives Program was established by the MAP -21 Federal Transportation Bill. It combines three previous programs into one. These programs were the Transportation Enhancements Program, Scenic Byways Program, and Safe Routes to Schools Program. In Minnesota, Scenic Byways Coalitions are eligible to receive these funds for projects to improve scenic routes.

TAP funds are distributed through the ATP process, so each MN/DOT District has dedicated funds for TAP projects. In the spring of 2014, there was a Scenic Byways Workshop held to discuss the Scenic Byways program and opportunity for the TAP funds. It was subsequently decided to contract with Regional Development Commissions to assist local scenic byway coalitions in planning for potential projects eligible for this new funding category.

The East Central Regional Development Commission service area includes two Scenic Byways: Veterans Evergreen Memorial Scenic Byway in Pine County and a major portion of the St. Croix Scenic Byway in Chisago and Pine Counties. Planning began in 2014 in relation to these byways.

Scenic Byway Description

The Veterans Evergreen Memorial Scenic Byway is located on TH 23 in Pine County. It starts at the I-35/Banning State Park exit and continues eats on TH 23 to Duluth. This byway is 50 miles in length and goes through the communities of Askov, Kerrick, Bruno, Duquette, and Bruno. There are also a number of townships along the route. There are also a number of



points of interest as well as local parks along this Byway. The large Evergreen trees are one of the scenic features along with the Kettle River, other streams, and spectacular vistas at a few locations. The roadway itself has been reconstructed and is in very good driving condition, making it a pleasant drive east.

Task Force Development & Planning Process

Bob Bollenbeck, ECRDC Transportation Planner, identified possible scenic byways task force members. One of the key players was Jan Ashmore, who coordinated the TH 23 Task Force in the 1990's and organized the designation process for the Veterans Evergreen Memorial Scenic Byway. Meeting with Jan, a number of players were identified and a mailing list developed including representatives from local units of government, MN/DOT, townships, former task force members, business leaders and local citizens.

The planning process included conducting local meetings to get input on possible projects, discussion of TAP program purpose and intent, and information on the byway such as the assets. Three meetings were planned.

Summary of Meetings

The first was held on July 17, 2014 at the Pine County Historical Museum in Askov. About a dozen persons were in attendance. The TAP planning process and program parameters were discussed with emphasis on developing potentials projects for TAP funding consideration. Examples of possible TAP projects were presented. Meeting materials are included in this report.

It was decided to hold the second meeting in

Duquette on August 28. Andy Gunderson, owner of the Duquette General Store, agreed to serve as Chair of the Committee. The second meeting was focused on identifying the Scenic Byway assets. Five categories of byway assets were discussed. Scenic, Archeological, Historical, Cultural, and recreational were identified and discussed. Mr. Tim Campbell, Minnesota Office of Tourism assisted the group in identifying the assets. A list of assets was compiled and made available. Materials from this meeting are included in this report.

The third meeting for the task force was held October 9 at Duquette City Hall. While there were only six persons participating, there was significant discussion and direction identified. Significant discussion included signage at each end and on the Byway as well as more visibility on Interstate I-35, possible projects in the Gary/New Duluth area, emphasis on "veterans". There was general agreement that the next steps for the Scenic Byway was to develop a viable structure to guide the byway development. Meeting materials are included in this report.

It is important to note that mailings were sent prior to each meeting and press releases

developed. In addition, ads in the local papers in Askov and Moose Lake (Shopper) were placed to attract the general public to this planning process.

Task Force Participants

A large mailing list of possible participants was developed and meeting announcements sent prior to each meeting. A core group of participants participated regularly and provided input. The mailing list in included in this report.



Action Plan to Move Forward

The Task Force discussed how to move forward. There was an overwhelming concern for organizational structure. This structure was seen as critical to moving any potential project forward as well as general impetus for Scenic Byway tourism. A number of projects were suggested during the planning process and were highlighted. Some of the projects were:

Clearing brush for better vista of the Evergreen trees, interpretive signage and displays highlighting local veterans, identification of historical sites in communities, mapping of points of interest, and potential trails.

The first task agreed upon was the establishment of a Veterans Evergreen Scenic Byway structure such as an ongoing committee to guide future development and activities of the Byway. It was agreed to meet again to start the discussions about moving forward.

The second task was to have prominent identifiable Scenic Byway Signs at the beginning and end of the route. Attractive signs would likely encourage more people to drive the route. There was much discussion about signage for the route on Interstate I-35. Details about this signage were briefly discussed. It was agreed this action item could be undertaken at the same time the Byways structure is being developed.

Conclusions/Final Comments

In previous planning activities, the driving force for local involvement was the improvement of the TH 23 roadway. Mn/DOT did indeed improve the road so it is now a good, smooth road surface. Since the road improvement happened, generating interest in this planning process was difficult. But this process resulted in increased awareness of the TAP program and funding.

There is no existing coalition to spearhead TAP projects for the Scenic Byway. In order to propose projects and receive funds, an organization must be organized.

Further Considerations for the Veterans Evergreen Memorial Scenic Byway:

- A. Since there is neither a viable Corridor Management Plan nor a cohesive byway group to guide byway decisions, the ECRDC could pursue development of a Corridor Management Plan (CMP). This would require a significant investment of time and other resources. We estimate developing a CMP to be in the range of **300 hours (approx. \$30,000)**. This also assumes the development of a viable scenic byway corridor organization/structure to administer the various work components.
- B. Another option might be to de-designate the corridor unless a structure can be developed.
- C. As a result of the above situation, we do not anticipate a plan update at this time.

Hello Highway 23 Stakeholder:

I am writing to invite you to participate in a local project to determine the future of Highway 23 in Pine County. We are working with MN/DOT to do some planning for the Veterans Evergreen Memorial Scenic Byway (Highway 23) in Pine County. The scenic byway corridor runs from I-35 to Duluth. The purpose of this planning is to identify a list of projects which would be eligible for Transportation Alternatives Program funding. Your input as a stakeholder along this corridor is vital to move this project forward.

Our first meeting will be held at the Pine Historical Museum in Askov on Thursday, July 17 at 6:00 PM. I expect this meeting will last about an hour to an hour and a half. We will provide light refreshments such as coffee and cookies.

We are pleased to be working with TH 23 Task Force Coordinator Jan Ashmore on this project. One of the first items for discussion will be Highway 23 upcoming improvements as well as history of work of the task force. Bryan Anderson, MN/DOT District 1 Planning Director will be on hand to discuss work scheduled for the Highway Corridor. We will also discuss this Scenic Byways project and get your input as to how to proceed.

Summary of the July 17, 2014 Veterans Evergreen Memorial Scenic Byway Meeting

The meeting was called to order by Bob Bollenbeck, ECRDC Transportation Planner. He welcomed all and thanked everyone for coming. Everyone introduced themselves. There were about 10 persons present. The agenda was reviewed. One member brought an "old' designation poster for this Byway.

Jan Ashmore, Highway 23 Task Force Coordinator, gave a brief history of the work of the task force. The task force was active for several years in the mid 1990's. She talked about the first meetings which focused on highway improvement. The town hall meeting in Duquette generated a large amount of interest. Planning with MN/DOT and others proved to be successful. This planning led the task force to develop the Veterans Evergreen Memorial Scenic Byway proposal and subsequent designation for Highway 23 from I-35 to Duluth.

Bryan Anderson, MN/DOT District 1 Planning Director gave an overview of upcoming construction work on Highway 23. Over the next 3 years a significant amount of money will be spent on west Duluth improvements. He described the project and costs. He indicated that the District will not have enough funds to even keep up with road preservation. Of course, there will be some funds available in categories such as Safe Routes to Schools.

Bob Bollenbeck then gave a summary of Scenic Byways elements and purpose of this planning process. He indicated that we will be developing a list of projects eligible for Transportation Alternative Program (TAP) funding. He summarized the intent and purpose of TAP funding and provided examples of potential projects. Bob then asked how we should proceed and who else should be involved.

There was much discussion on who else might be involved. The business community should be more involved was a general consensus. It was stated that we'll likely need to bring the project to local businesses. Others mentioned include Veterans groups. Daughters of American Revolution (DAR), DNR and Banning State Park. Contact names were offered.

Sam Griffith stated he had contacts for Tribal Historical Preservation for Mille Lacs and Fond du Lac.

He also suggested there was much work done with the St Croix Initiative, which has an inventory of assets helpful to this planning activity.

Bryan Anderson said he was meeting with someone who might be able to help with some strategic planning relative to identifying cultural, historic, and archeological assets of the area.

The next meeting was identified for August 28 in Duquette at 6:30.

- 1. **Project Status** Bob Bollenbeck gave a brief report on the status of the project. He reported that we have identified assets of the Byway and now the task is to identify potential projects for TAP funds as well as others.
- 2. **TAP Eligibility** Bob Bollenbeck distributed information from a recent TAP workshop concerning project eligibility and funding qualifications. This information was briefly reviewed and discussed.
- 3. **Byway Project Identification/Brainstorming** Bob stated that it would benefit to have noteworthy bookends for the Byway in order to attract travelers to the route. There was much discussion about developing prominent signage at each end of the Byway. Sam also noted the importance of letting folks know that, along the way, they are ON the Byway with points of interest and such. It was agreed that signage on the Interstate would be beneficial.
